# Announcement for Persons Who Anticipate Not Being Able to Receive the Full Fixed Amount Tax Reduction

The FY2024 tax reforms will introduce a fixed amount tax reduction of the estimated income tax for 2024 and individual inhabitant tax for 2024.

Persons for whom the deductible amount exceeds the amount of tax before the reduction and therefore cannot receive the full fixed amount tax reduction will be paid the difference. For more details, please see the Suginami City website (OR code to the right).



#### Eligibility

Those who reside in Suginami City as of January 1, 2024, and for whom the deductible amount is expected to exceed the estimated income tax and individual inhabitant tax per income levy (\*) (however, only those whose total income is 18.05 million ven or less are eligible).

\*Those whose estimated income tax amount for 2024 and individual inhabitant tax per income levy for 2024 (both calculated based on income earned during 2023) are both 0 yen (tax-exempt) will not be eligible.



We will send a notification to eligible persons around late July. Those who receive a notice of payment will not need to apply. Those who receive a notice of confirmation should apply by post or online via the special website by October 31.

# **Cut Down on Wastewater During Heavy Rainfall!**

The upcoming season will see the occurrence of typhoons and seasonal rain fronts, which can lead to flood damage in no time at all following short bursts of intense rainfall.

Almost all areas in the city have a system for directing domestic wastewater from homes and rainwater into the sewers. When there is heavy rainfall, water levels rise in the sewers, potentially causing water to overflow and burst out from manholes and other openings. During heavy rainfall, please avoid activities that use a lot of water at one time, such as taking showers, washing dishes, and doing laundry.


#### Flood Hazard Map

The Flood Hazard Map shows places in the city where flooding has occurred in the past, and includes predicted flood areas and water levels.

# Sending out Notifications of the Amount of National Health Insurance Premiums

We will send out Notifications of the Amount of National Health Insurance Premiums for FY2024 to the heads of households on June 13 (Thursday). Insurance premiums for the period from April 2024 to March 2025 should be paid in 10 installments from June 2024 to March 2025. Payment slips for a lump-sum payment for the entire year or for payments in periodic installments will be enclosed for residents who will pay the

insurance premiums, in part or in full, using payment slips.

# Foreign Residents Must Also Enroll in the National Pension System

All persons between the ages of 20 and 59 residing in Japan are legally obligated to enroll in the National Pension System and pay contributions regardless of their nationality (excluding those who are covered under the Employees' Pension, as well as their dependent spouses).

However, systems, such as a contribution waiver system, have been put in place to support those who would face hardships in paying the contributions due to low income or other reasons.

If a foreign resident has fulfilled certain criteria, such as paying National Pension System contributions for 10 years or more, in principle, he or she will be eligible to receive benefit payments through the Old-age Basic Pension from age 65. The Disability Basic Pension, which provides benefits to those who become seriously disabled due to an illness or injury, and the Survivors' Basic Pension, which is provided when the primary breadwinner of a household passes away, are also available.

Certain countries have also concluded social security agreements with Japan and have established frameworks that prevent dual enrollment in their respective pension systems or allow citizens to receive the total sum of each pension based on their pension enrollment period in both countries. Foreign residents who

have paid contributions for six months or more but are not eligible to receive benefit payments through the Old-age Basic Pension may request a lump-sum withdrawal payment upon leaving Japan. The request must be made within two years after the day he or she no longer has an address in

2024年1月1日現在杉並区に居住し、定額減税可能額が推計所得税・個人住民税所得割(※)を上回ると見込まれる方(ただし、合計所得金額が1805万円以下の方のみ)

※2024年分推計所得税額、2024年度個人住民税所得割額(いずれも2023年中所得金額から算出)がどちらも0円(非課税)の場合は対象外。

# 大雨の時は排水を抑える行動を!

これからの時期は、台風の発生や梅雨前線などの影響で、短時間に非常に強い雨が降るなど、わずかな時間で水害をもたらす可能性があります。 区内のほぼすべての地域は、家庭から出る生活排水と雨水が下水道に流れ込む仕組みになっており、大雨が降ると、下水道内の水位が上昇し、マンホールなどから 水があふれる恐れがあります。 大雨時には、シャワー・皿洗い・洗濯を控えるなど、一度に多くの水を流さないようにご協力をお願いいたします。

# 国民健康保険料額通知書を発送します

2024年度保険料額通知書を6月13日(木)に世帯主宛てに発送します。4月~2025年3月の保険料を、6月期~2025年3月期の10回に分けてお支払いいただきます。

保険料の全部または一部納付書払いの方には、一括分と各期分の納付書を同封します。

# 外国籍の方も国民年金に加入が必要です

日本に住む20~59歳の方は、国籍に関係なく国民年金に加入し保険料を納めることが法律で義務付けられています (厚生年金加入者、厚生年金加入者に扶養されている配偶者を除く)。

ただし、所得が少ないなどの理由で保険料を納めることが困難な場合には、保険料免除などの制度が設けられています。

国民年金保険料を10年以上納めたなどの条件を満たすと、原則65歳から老齢基礎年金が支給されます。また、病気やけがで重い障害が残っ たときには障害基礎年金、働き手が亡くなったときには遺族基礎年金が支給されます。

なお、日本と社会保障協定を結び、年金制度の二重加入の防止や、両国の年金制度の加入期間を通算して年金が受けられるような仕組みを 設けている国もあります。また、保険料納付済期間が6カ月以上あり、老齢基礎年金の受給資格を満たしていない外国籍の方は、日本に住所を 有しなくなった日から2年以内に脱退一時金を請求することができます。
